

Dear parent/guardian,

Diamond Valley SDS is looking forward to another great year of teaching and learning and would like to advise you of Diamond Valley SDS's voluntary financial contributions for 2024.

You may be aware that schools provide students with free instruction to fulfil the standard curriculum requirements and we want to assure you that all contributions are voluntary. The ongoing support of our families ensures that our school can offer the best possible education and support for our students. We want to thank you for all your support, whether that is through fundraising or volunteering your time. This makes a big difference to our school and the programs we can offer.

Within our school this support has allowed us to organise and coordinate the best possible programs for our students. These financial contributions assist us with:

*The purchasing of art, music and physical education equipment and resources, which in turn, supports them to be exemplary programs that coincide with our classroom teaching. Some of the other programs which we can offer because of your contributions include bicycle education, cooking, music sessions, swimming, horse riding and community access.

* Allows us to have online subscriptions to resources that supports learning in the classroom.

* We are also able to subsidise student celebration days such as Footy Day, Blossom Day and end of term group celebrations.

* Upgrade and purchase of additional IT devices and technology for the classrooms.

All of these programs running alongside the traditional classroom teaching and learning programs are imperative to provide an effectively balanced education for your children.

In 2024, parents/carers of our students are asked to contribute \$240 per child for the year towards curriculum contributions items. Among other things these include all stationary used in the classroom, materials for cooking and sensory programs, printing, and photocopying.

Parents/carers are asked to pay for extra-curricular items and activities such as horse-riding and when a new PODD book is provided to students. Also, when optional excursions or camps are scheduled, we will ask that you cover these costs and ensure you are given ample time to make payment arrangement for these optional activities. These are provided on a user-pays basis.

Diamond Valley SDS is endorsed as a Deductible Gift Recipient under the *Income Tax Assessment Act 1997 (Cth)* with the result that any donations made by you will be tax deductible. To be tax deductible, your donation needs to be made voluntarily, therefore you are able to add an amount to be contributed under "Curriculum Contributions" below. Amounts paid under "Extra-Curricular Items and Activities" are not donations and are not tax deductible.

Financial Support for Families

Diamond Valley SDS understands that some families may experience financial difficulty and offers a range of support options, including:

- The Camp, Sports & Excursion Fund is a government provided payment that contributes towards the cost of camps, sports and excursions for parents or carers with a current Health Care Card. Parents who currently receive the CSEF and who remain eligible will automatically have their 2024 application processed by the school. This payment is \$125 for primary aged students.
- State Schools Relief This organisation may cover the cost of new school uniforms, shoes, books and more for disadvantaged students. State's School's Relief work directly on applications submitted by school's so please contact the Claire Toll or Robyn Marett if you would like to discuss this option.
- Flexible payment options can be arranged to suit your individual financial circumstances.
